Conditions of Entry

1. Stall holders must use the exhibitor's entrance only, this is clearly sign posted.
2. All applications must be submitted on the enclosed form which must be signed and returned with your payment by 20th April 2025. Allocation of all spaces will be at the discretion of the show committee who have the right to refuse any applications.
3. The Showground will be open from **10:00am – 6pm Friday 16th May** to allow time to set up. **Stall holders must leave their pitch by 7:00pm Sunday 18th May**.
4. All exhibitors and traders are responsible for their own property Anglesey Vintage Equipment Society will **NOT** accept any responsibility for damage or loss.
5. Stall holders must ensure they have booked a pitch large enough.
6. Sub letting is strictly prohibited.
7. All gangways must be kept clear of tables, signs etc at all times.
8. Waste disposal skips will be provided for your rubbish, please ensure your pitch is clear of any waste before you depart the showground.
9. Please enclose a copy of your public liability insurance. All exhibitors and traders must also be able to provide proof of valid insurance at the event.
10. Each trader is responsible for their own risk assessment and may be asked to produce at any time.
11. Animals must be kept on a lead at all times, please ensure any fouling is cleared up immediately.
12. One acceptance form will be issued per space; this will allow entry for two persons.
13. Additional passes for larger stands please speak to the section leader prior to your arrival, these will be issued at the discretion of the show committee.
14. Please respect the property and facilities offered to us by the Anglesey Agricultural Showground.
15. Please note vehicle movement is restricted during show hours. We operate strict policy of no movement between 10am to 5pm Saturday & 10am to 4pm Sunday.
